- **Preparing children for citizenship in our community is one of the purposes of all Haleyville Schools. With that purpose is the skill of “giving back” or “paying forward” by encouraging students to participate in Community Service Projects. The DECA Club and the SGA (Student Government Association) are coordinating two outstanding projects: The DECA Club will be selling pink “Breast Cancer Awareness” T-shirts with all proceeds going to the American Cancer Society. This project will be throughout October. The SGA will sponsor a Blood Drive on Monday of the week of Thanksgiving. The SGA has sponsored blood drives at school for many years and this is the second or third year for DECA’s breast cancer awareness project. Please support our students in these Community Service Projects as both are very worthwhile endeavors in addition to teaching our students the discipline of good citizenship.**

- **Your elected members of this School Board take their responsibilities very seriously and are committed to developing critical leadership and boardmanship skills that improves their duty as a member. Professional Development is offered through the Alabama Association of School Board’s “School Board Member Academy.” Tonight, two of our members are recognized for their advancement in the Academy. Our president, Mr. Steve Stott, is awarded a**

Certificate of Achievement by meeting the requirements of having completed 50 academy hours for 2010-2011. Ms. Sandra Manasco, our longest sitting member, is recognized as reaching the highest level of the Academy, that of “Master’s Honor Roll.” This means Ms. Manasco has earned Master Level IV requirements of 100 academy hours, all eight core courses, plus 15 additional hours for five consecutive years! She will also be recognized at AASB’s annual convention in December with a special “gold” name badge and tonight she receives an Honor Roll plate to be affixed to her Master’s plaque. Congratulations to both, Mr. Stott and Ms. Manasco.

- **Last month two major grant awards for our system were announced and again this month good news has arrived. Yesterday we were notified that our application for Universal Service Support, or eRate as it is referred to, has been approved for \$190,258.60 to assist with systemwide technology upgrades. This award will allow wireless access points at and between all four campuses plus replacing aging switches and routers throughout all school buildings. This is indeed a welcome assistance as we have not been State funded for technology for the last three years. It does require a 20% match of \$30,441.38 which will come from the new revenue sources of taxes provided the system by the Mayor and City Council.**
- **This Board held a Work Session earlier today with all members except Mr. Haughton present. Discussions centered on immediate and future needs and concerns of the system. No official business was transacted. The next scheduled meeting of this Board is October 25, to be held in the Board Room of HHS at 7:00 p.m. with a Work Session prior if necessary.**
